**TICKER** CNO Financial Group, Inc. is a publicly traded company under the ticker CNO on the New York Stock Exchange (NYSE).

**LOCATIONS** We are headquartered in Carmel, Indiana. Carmel is home to Washington National and 40|86 Advisors, Chicago is home to Bankers Life and Philadelphia is home to Colonial Penn.

**EMPLOYEES** We employ approximately 3,300 full-time associates. More than 1,300 work in Indiana, the home of our headquarters.

**CUSTOMERS** CNO Financial's insurance subsidiaries provide more than 3.5 million policies to middle-income working Americans and retirees.

**FINANCIAL POSITION** CNO Financial is one of the 10 largest public companies in Indiana, with a market capitalization of \$2.6 billion (as of 3/31/2019). The company is financially strong and well positioned for continued growth. In 2018, CNO Financial reported:

- \$4.3 billion in revenue and \$303 million in net operating income
- \$1.83 of net operating income per diluted share
- Strong capital position, including \$220 million in holding company liquidity, allowing CNO Financial to withstand periods of market stress

The subsidiaries of CNO Financial Group—Bankers Life and Casualty Company, Colonial Penn Life Insurance Company and Washington National Insurance Company—are rated A- (Excellent) by A.M. Best, the global rating agency for the insurance industry.

**LEADERSHIP** CEO Gary C. Bhojwani and his leadership team bring extensive insurance industry experience, knowledge and perspective to CNO Financial.

**HISTORY** The company's predecessor, Conseco, Inc., was incorporated in 1979, began operations in 1982 and became a public company in 1985. The company re-branded to CNO Financial Group, Inc. in 2010.

**RECOGNITION** In 2018, CNO Financial was named among both the World's Best Employers and America's Best Employers by *Forbes*. We were also honored with the *Best Employers for Healthy Lifestyles*® Platinum award, and we were recognized as one of the Healthiest 100 Workplaces in America.
